FROM THE BOARD:

BELATED 2020 ANNUAL MEETING AND ELECTION: The Board will proceed with holding the belated 2020 Annual Meeting and Election on Thursday, April 29th, at 6:00 PM. Sign-in for all owners will begin at 5:30 PM and the meeting will begin promptly at 6:00 PM. A meeting package (including a cover letter to all owners, Notice of Belated 2020 Annual Meeting, Meeting Agenda, blank Proxy form and resumes of two candidates) will be mailed shortly.

Because of continuing Covid-19 restrictions, this belated Annual Meeting and Election will be held on the back patio of the Community Center. The Board members will be seated on the patio with owners bringing their own lawn chairs and sitting socially distant from each other on the lawn. Additionally, all Board members and attendees are requested to wear masks.

There are two three-year term Board positions open for the period July 2020 through July 2023. Currently, there are two candidates on the ballot, but other nominations will also be welcomed and accepted from the floor on election night. All voting will take place either in person or via proxy. After the ballots are collected and counted, the results will be announced that evening. After the meeting, the current and newly-elected Board members will meet to decide which individual Board positions will be held by whom and then will be announced in the May 2021 Newsletter.

50.1% of the Association membership must be present either in person or by proxy to represent a quorum. If you are unable to attend the meeting, please ensure you have a valid Proxy form on file to ensure that your vote is counted. Your proxy form will remain valid for five (5) years and enables you to name another PRCUOA owner or Board member to cast a vote for you.

Lastly, we will also need to schedule a 2021 Annual Meeting and Election for July 2021. Voting will occur at that time for two more three-year term Board positions that will run from July 2021 through July 2024. Further details will be forthcoming concerning that meeting.
